THE HARMONY PROGRAM HAS DEVELOPED A PROPRIETARY CURRICULUM FOR 6 SEMESTERS OF INSTRUCTION ON EACH OF 8 ORCHESTRAL INSTRUMENTS (INCLUDING STRINGS, WINDS, BRASS, AND PERCUSSION), AND A CHORAL CURRICULUM FOR STUDENTS TO LEARN VOCAL TECHNIQUE. OUR CURRICULA ARE BASED ON THE NATIONAL ASSOCIATION FOR MUSIC STANDARDS, AS WELL AS THE NYC BLUEPRINT FOR TEACHING AND LEARNING IN MUSIC. AFTER-SCHOOL INSTRUCTION TAKES PLACE 3 TO 10 HOURS EACH WEEK FOR 30 WEEKS DURING THE SCHOOL YEAR (UP TO 300 HOURS ANNUALLY). AT THE END OF EACH SEMESTER, STUDENTS ARE EVALUATED BY TEACHERS ON THEIR MUSICAL AND SOCIAL DEVELOPMENT. MUSICAL EVALUATIONS ARE USED TO ASSESS THEIR PROGRESS ON AREAS OF TECHNIQUE, MUSIC THEORY, AND MUSICIANSHIP, INCLUDING BODY POSITION, INSTRUMENT HOLD, NOTATION, TONE QUALITY, TEMPO/RHYTHM, VOCAL RANGE, INTONATION AND
